AN ORDINANCE OF THE ANCHORAGE ASSEMBLY AMENDING ANCHORAGE MUNICIPAL CODE TO ENACT AND CODIFY LIMITATIONS ON THE ANCHORAGE POLICE DEPARTMENT'S USE OF FORCE POLICIES.

WHEREAS, there is great public interest across the nation in police departments' policies and procedures; and

WHEREAS, the Anchorage Police Department policies and procedures include section 3.05.025, "Response to Resistance," setting forth guidelines and limitations concerning the appropriate and acceptable use of deadly and nondeadly force by police officers in performance of their duties, with the safety of innocent persons and officers of paramount importance; and 13

15 WHEREAS, enacting restrictions and limitations on APD Officers use of force in response to resistance in the Anchorage Municipal Code will establish them as 16 public policy vetted and supported by the Anchorage Assembly, the legislative 17 branch of the Municipality, provide consistency and transparency of the prohibited 18 19 methods of restraint and force, and require an ordinance and public hearing to modify by Code amendment; and 20

WHEREAS, this ordinance proposes codifying some restrictions and limitations that are substantially similar to ones in the current APD policies and procedures with the addition of a prohibition on sitting, kneeling, or standing on a person; now therefore:

Section 1. Anchorage Municipal Code chapter 8.100 is hereby amended and a new section added to read as follows:
