**APPLICATION FOR RECOUNT – DISTRICT 27
(AS 15.20)**

Carolyn “Care” Clift, Robert Edward Clift, Donald Crafts, Susan M. Kent-Crafts, Lynne Vaughn, James Mark Vaughn, Margaret Nelson, Brad Campbell, Shannon Carte, Jeff Garness and Lisa Garness hereby apply for a recount of the State House race in the November 2020 general election for House District 27 pursuant to AS 15.20.430-440. Pursuant to AS 15.20.430(a), we as at least 10 qualified voters in House District 27 believe that mistakes have been made by an election official that could change the outcome of the election. We are therefore eligible to file this application.

The basis of this application is the following:

1. Failure to count votes cast for Lance Pruitt where the voter intent was clear.
2. Inclusion in the final vote count of multiple questioned ballots.
3. Failure to ensure that absentee voter ballot certificates were properly completed.
4. Failure to properly confirm the results following an electronic count given publicly reported issues with the Dominion voting system recently acquired by the State of Alaska.
5. Last minute and unnoticed change in a precinct location resulting in voter confusion and errors in the ways ballots or questioned ballots were cast and counted.

Jeff Garness shall serve as the Chair for the qualified voters. The full name and mailing address of the two persons who shall represent us and be present and assist during the recount are:

As the official results certified by the Division indicate a 13-vote margin (equal to 00.14%) between the two competitors, no deposit is required and the State shall bear the cost of the recount pursuant to AS 15.20.450.






