First Day

Pursuant to the provisions of the Constitution of the State of Alaska, the House of Representatives of the State of Alaska assembled in the House Chamber for the first regular session of the Third State Legislature, January 28, 1963, at 10:20 a.m. and was called to order by the Honorable Hugh J. Wade, Secretary of State.

Secretary of State Hugh J. Wade then read the following certificate of election:

Proposal:

That the Clerk of the Superior Court, First District, be requested to prepare two slips of paper, of equal size and and to mark on one the words, "Republicans organize", and on the other the words, "Democrats organize", and to insert the slips in envelopes of the same size, shape, and color, and to deposit them in the jury box in the court room of the said Superior Court in the presence of the members of the House; that the Judge of the said court be requested to spin the jury box in the same manner as in the selection of the jurors under the laws of Alaska and that he draw from such box one of the two envelopes placed therein; that if he shall draw the envelope bearing the slip marked "Republicans organize" then the temporary Speaker, the permanent Speaker, and the chairmen of the standing committees shall be Republicans selected by the Republican caucus, and if he shall draw the envelope bearing the slip marked "Democrats organize", then the temporary Speaker, the permanent Speaker, and the Chairmen of the standing committees shall be Democrats selected by the Democratic caucus, and in either event, the party organizing their House shall have a majority of one on each committee. The drawing of the envelope shall be in the Superior Courtroom in the presence of the members of the House.

Mr. Boardman rose to a point of order.

Mr. Strandberg moved and asked unanimous consent that the House recess for five minutes. Without objection it was so ordered.

AFTER RECESS

The House was called to order at 2:20 p.m.

Mr. Boardman moved and asked unanimous consent that the House recess until 3:15 p.m. Without objection, it was so ordered.

AFTER RECESS

The House was called to order at 3:15 p.m.

Mr. Boardman removed his objection to Mr. Rader's motion which was based on the point of order.

Mr. Rader rephrased his motion and moved that the House accept

the proposal stated and that the House recess to execute the same. Mr. Gravel seconded the motion.

(The full text of the Governor's message appears as a supplement to today's journal.)

On conclusion of the Governor's message, members of the Senate and House and those present in the gallery gave Governor Egan a rising vote of thanks, and he was then escorted from the Chamber by Senator Smith and Representative Longworth.

Mr. Boardman moved and asked unanimous consent that the Joint Session adjourn. There being no objection, the Joint Session adjourned at 8:47 p.m.

AFTER RECESS

The House was called to order at 8:50 p.m.

Mr. Boardman moved and asked unanimous consent that the House adjourn until 8:45 a.m., February 5, 1963, in order to hear the Governor's budget message at 9:00 a.m. Without objection, the House adjourned at 8:55 p.m.
