COMPLAINT

COMES NOW the plaintiff, Ms. Bobbie McDow, by and through counsel, the Northern Justice Project, LLC, and alleges and requests relief as follows:

INTRODUCTION

1. Alaska State Senator Lora Reinbold is suppressing free speech. She has banned her constituent, Bobbie McDow, from the "Senator Lora Reinbold" Facebook page, and has removed McDow's comments – all because McDow posted critiques of State Senator Reinbold's position against wearing masks during a pandemic.

2. State Senator Reinbold's mindlessness is not surprising: she has accused Alaska Airlines of "mask tyranny," been banned from Alaska Airlines for violating its mask policy, publicly criticized Governor Dunleavy's vaccination efforts in Alaska, and been banned from parts of the Capitol for violating basic COVID-19 guidelines.

3. Now, State Senator Reinbold is violating the Alaska constitution by discriminating against Ms. McDow based on her viewpoint. Because of her viewpoint, Ms. McDow is banned from commenting on posts on the public and interactive "Senator Lora Reinbold" Facebook page. She is also banned from liking or otherwise reacting to State Senator Reinbold's posts, from replying to or liking the comments of other users, from conversating with other users, and from messaging State Senator Reinbold.

4. Our democracy is founded on the notion of a full and fair exchange of ideas and on the premise that all citizens can petition their government about their concerns and their complaints. State Senator Reinbold wants to eliminate from this conversation anyone who disagrees with her positions, something more akin to Communist China than to the United States of America. State Senator Reinbold's actions are not only anti-democratic, they are also unconstitutional.

- 5. The plaintiff, Bobbie McDow, is a resident of Eagle River, Alaska.
- 6. The defendant, Lora Reinbold, is the Alaska State Senator for District G.



9. The Facebook page at issue is titled "Senator Lora Reinbold" and names her as a "Government Official." The page displays the Declaration of Independence, U.S. Constitution, and Alaska flag. The page's "About" section says it is intended "to help educate viewers about issues facing our state." The page is "liked" and "followed" by thousands of people. A screenshot is below:1



10. The Facebook page at issue was created on January 25, 2013, when Ms. Reinbold was first elected to the Alaska legislature. In 2013, the page was initially named "Representative Lora Reinbold," corresponding with her service in the Alaska House of Representatives from 2013-2019. Then, on January 25, 2019, the page was renamed "Senator Lora Reinbold," corresponding with her 2019 election to the Alaska Senate. This is confirmed by the below screenshot of the page's "Transparency" section:

11. The "Senator Lora Reinbold" Facebook page is *not* Ms. Reinbold's personal Facebook page. These two pages are distinct. Instead, Ms. Reinbold's personal page was created around July 2009, years before she was elected to the Alaska legislature, and years before the "Senator Lora Reinbold" Facebook page was made. Her personal page has many fewer "followers" than the "Senator Lora Reinbold" Facebook page. This is confirmed by the below screenshot of the "Lora Reinbold" Facebook page:²







- 14. The "Senator Lora Reinbold" Facebook page also includes hundreds of posts and comments about political matters. It routinely features Ms. Reinbold making announcements about legislation or political matters, providing links to news articles, giving responses to current political events, and more.
- 15. Sometimes, the "Senator Lora Reinbold" Facebook page makes multiple posts in the same day. It is frequently updated with new information.
- 16. For instance, on April 27, 2021 at 1:40 PM, the page published a post leading with "URGENT NOW: CALL IN PUBLIC TESTIMONY: NO on SB 124!..." A screenshot of this post, which is just one of many examples of posts, is below:

- 18. Then, again on April 27, 2021, at 11:35 PM, the page published a video of Ms. Reinbold talking about HB 76 concerning the state's Disaster Declaration.

19. Typically, people can interact with the "Senator Lora Reinbold" Facebook page by "liking" the posts on the page, or by responding to the posts with various emojis. For instance, in the post below, Senator Reinbold is criticizing mask wearing and advocating for an "Open Alaska." A user can respond with a thumbs up "like" emoji, a heart emoji, an anger emoji, and more. This is confirmed by the below screenshot.





20. A single post by the "Senator Lora Reinbold" Facebook page can generate dozens of the aforementioned reactions. For instance, on April 26, 2021, Ms. Reinbold posted a link to a YouTube video about her driving through Canada to get to the Capitol after she was banned from Alaska Airlines. In response, at least 57 people responded with "Haha" emojis, while others "liked" or even "loved" the video in question. This is confirmed by the below screenshot:

- 21. Typically, people can also interact with the "Senator Lora Reinbold" Facebook page by commenting on the page's various posts, by reading the comments of others, by responding to the comments of others, and by reading those responses.
 - 22. Posts on the page have generated thousands of comments and replies.
- 23. As just one of many examples, on April 6, 2021, the "Senator Lora Reinbold" Facebook page posted an article about Texas restricting "vaccine passports." In response, some people commented by critiquing the thrust of the article, while others responding by defending it. Meanwhile, some commenters directly engaged with one another about the issue in replies. This is confirmed by the below screenshot:





For instance, in the screenshot below, Ms. Reinbold makes a post about Alaska's Legislative Council, one commenter asks a question about governing rules, and Ms. Reinbold responds.









Indeed, these platforms allow ordinary citizens to speak directly to public officials, and also to listen to and debate with one another about public issues.

The "Senator Lora Reinbold" Facebook page is a source of news and information for Ms. Reinbold's constituents, and others, about the government and the representation (or lack thereof) of their interests. The page is a public forum for speech by Ms. Reinbold, to Ms. Reinbold, about Ms. Reinbold, and for speech in general.
 - 28. Bobbie McDow is a constituent of Ms. Reinbold.
 - 29. Ms. McDow has used the "Senator Lora Reinbold" Facebook page.
- 30. In the past, Ms. McDow has commented on Ms. Reinbold's posts on the "Senator Lora Reinbold" Facebook page.
- 31. For instance, Ms. McDow commented on a post on the "Senator Lora Reinbold" page on February 19, 2021, which is confirmed by the screenshot below:




- 39. However, as of April 29, 2021, Ms. McDow has been banned from the "Senator Lora Reinbold" Facebook page.
- 40. According to Facebook, "[w]hen you ban someone from your Page, they'll still be able to share content from your Page to other places on Facebook, but they'll no longer be able to publish to your Page, like or comment on your Page's posts, message your Page or like your Page." This is what has happened to Ms. McDow.







47. It even appears that Ms. McDow's past comments and replies have been removed or hidden from the "Senator Lora Reinbold" Facebook page. For instance, in Reinbold's March 27, 2021 post on COVID-19 pseudoscience, there are many comments where people are conversating with Ms. McDow, mention her by name, and directly respond to her comments and replies. However, Ms. McDow's comments and replies no longer appear in the thread. This is shown on the following two pages of screenshots:



48. Ms. McDow was restricted from accessing the "Senator Lora Reinbold" Facebook page because she commented critiques of Ms. Reinbold. For instance, Ms. McDow commented a critique of Ms. Reinbold's position against wearing masks during the COVID-19 pandemic. Ms. McDow also commented urging Ms. Reinbold to devote her efforts to funding domestic violence shelters and solving Alaska's budget crisis.

49. Regardless, this viewpoint discrimination against Ms. McDow has inhibited Ms. McDow's participation in and access to a public forum. It has also imposed an unconstitutional restriction on Ms. McDow's right to petition the government for the redress of grievances.

CLAIMS FOR RELIEF:

FIRST CAUSE OF ACTION – VIOLATION OF THE RIGHT OF FREEDOM OF SPEECH AND ASSOCIATION UNDER ALASKA CONSTITUTION ARTICLE I

50. The foregoing paragraphs of this Complaint are incorporated herein as though fully set forth.

In the area of free speech and association, the Alaska Supreme Court has repeatedly recognized that protections under the Alaska Constitution are broader than those recognized under the federal constitution. See e.g., Club Sinrock, LLC v. Municipality of Anchorage, 445 P.3d 1031, 1037 (Alaska 2019); Vogler v. Miller, 651 P.2d 1, 3-6 (Alaska 1982); Breese v. Smith, 501 P.2d 159, 166-72 (Alaska 1972); Wickwire v. State, 725 P.2d 695, 703 (Alaska 1986); Alaskans for a Common Language v. Kritz, 170 P.3d 183, 198 (Alaska 2007).

53. State Senator Reinbold's banning of Ms. McDow and the removal of her comments from the "Senator Lora Reinbold" Facebook page violates Article I of the Alaska Constitution because it imposes a viewpoint-based restriction on Ms. McDow's participation in a public forum; because it imposes a viewpoint-based restriction on Ms. McDow's access to official statements and news that Ms. Reinbold otherwise makes available to others; and because it imposes a viewpoint-based restriction on Ms. McDow's ability to petition the government for redress of grievances.

PRAYER FOR RELIEF

WHEREFORE, Ms. McDow respectfully requests that the Court grant:

- (1) Declaratory and injunctive relief against the defendant;
- (2) The costs and expenses of litigation, including full attorney fees;
- (3) All other relief as the Court deems necessary.
