Assembly Member Jamie Allard committed misconduct in office on August 11,2020
by Violating EO-15, an emergency order intended to protect the health and safety of
Anchorage citizens, issued by the Mayor of Anchorage pursuant to AMC 3.80.060(H)
by: 1) knowingly participating in an indoor gathering of more than 15 people (a
meeting of the Anchorage assembly) and 2) continuing to participate in an indoor
gathering of more than 15 people at a meeting of the Anchorage Assembly after
being specifically informed of the violation. Assembly member Jamie Allard failed to
perform prescribed duties as an assembly member. Of all citizens in Anchorage
Assembly Members should have been scrupulous in obeying the gathering
limitations established by paragraph 4 of E0-15. Allard's willful, intentional failure to
do so needlessly endangered the lives of Anchorage citizens, encouraged the
spread of COVID-19 throughout the community, and merits recall from office.
