Summary of complaint against Rep Jennie Armstrong

This complaint alleges that Representative Jennie Armstrong committed multiple violations in her 2022 campaign filings and her 2023 Legislative POFD filing, including:

AS 15.13.040

Unpaid expenditures at the end of a reporting period must be disclosed as debt.

2 AAC 50.740. (b)(1)

Reporting indebtedness to persons who have a substantial interest in legislative or political action.

2 AAC 50.384. (a)

Disbursing unused campaign contributions within a set timeframe.

2 AAC 50.384. (b)(2)

Approved methods of disbursing unused campaign contributions.

2 AAC 50.344.

Louisiana residents are subject to Alaska reporting requirements.

AS 39.50.030. (d)(3); and (h)(1)

Legislator disclosure requirements for POFD filings.

AS 24.60.070. (d)

Close economic association of this nature must be disclosed.

AS 24.60.990. (a)(1); (a)(9); (a)(12); (a)(13); and (b)(2)

Relevant definitions.

Narrative description of facts:

In Rep Armstrong's 2023 POFD report covering the period from 1/1/2022 through 12/31/2022 no debt to her attorney was disclosed. At that point in time, her APOC campaign filings indicate that she owed a \$9,000 debt to her attorney which was later paid in January 2023 on her "year end" campaign disclosure. In addition to that amount, Jennie Armstrong's August 2023 social media posts indicate that she owed at least \$45,000 more to her attorney, debt that she carried through the entire 2023 legislative session. Because this debt was presumably owed to Scott Kendall, a person with substantial interests in both legislative and political action, reporting is required as described by 2 AAC 50.740. (b)(1); AS 24.60.070. (d); AS 39.50.030. (d)(3); and (h)(1)

It is reasonable to presume that Attorney Scott Kendall was paid legal counsel for Representative Armstrong based on statements made by Rep Armstrong to the media, the presence of Scott Kendall in the courtroom representing Rep Armstrong, news coverage of the case, etc. Under ordinary circumstances a debt to an attorney may not be necessary to disclose however according to 2 AAC 50.740. (b)(1); AS 39.50.030. (d)(3) and (h)(1); AS 24.60.070. (d); and definitions in AS 24.60.990. Scott Kendall represents a clearly described case of an individual with "substantial interest in legislative, administrative, or political actions."

From Sept 30th, 2021 to present day Scott Kendall has served as the official registered agent for the LLC "Alaskans for Better Elections, Inc" entity #10110064. In calendar year 2021 "Alaskans for Better Elections" spent \$150,000 on lobbyists, in calendar year 2022 they spent \$75,000 on lobbyists, and in 2023 they spent \$75,000 on lobbyists. These expenditures are disclosed and logged in the State of Alaska lobbyist database. These lobbying contracts occurred before and during the period Rep Armstrong owed her debt of at least \$45,000 to her attorney, Scott Kendall. Scott Kendall also testified in front of the legislature in his own personal capacity. At one point in the 2023 session Scott Kendall testified on HB99 which was prime sponsored by Rep Armstrong, without either party disclosing to the legislative body that Rep Armstrong (presumably) owed Scott Kendall no less than \$45,000. This incident violated AS 24.60.070.(a)(2); (b); and (d).

In regards to her 2022 campaign disclosures, Representative Armstrong's filings are mathematically impossible and violate Alaska statutes. In her 2022 campaign, Rep Armstrong reported a total income of \$58,878.05 and a total expenditure of \$42,735.30 on her year end report. This would leave her campaign with a \$16,142.75 surplus, however she reported her final account balance as \$0 with \$0 surplus and \$0 debts. Rep Armstrong has a gap of \$16,142.75 based on her year end report which is unexplained.

Those numbers may partly come from a series of mathematical accounting errors, however, by adding every individual contribution across every campaign disclosure filed by Rep Armstrong in 2022 the total sum of contributions comes out to \$58,887.05. Using the same method to calculate all disclosed expenditures across all reports, Rep Armstrong reported a total of \$57,005 in expenditures. This leaves Rep Armstrong with a surplus of \$1,882.05. There is no record anywhere in her 2022 campaign filings of what Rep Armstrong did with this surplus of \$1,882.05. Rep Armstrong did not disclose the existence of any surplus. If Rep Armstrong spent this money during the campaign, AS 15.13.040 requires that her expenditures be disclosed. If Rep Armstrong did not spend the \$1,882.05 during the campaign period, she is required to disperse the surplus in accordance with 2 AAC 50.384. (a) and her APOC filings must show that these funds were disbursed in methods approved by 2 AAC 50.384 (b)(2).

In order to mitigate a potential point of contention, as a candidate in Alaska State elections, Louisiana residents are required to comply with Alaska State Law as per 2 AAC 50.344.

2010 election

Kendall served as a legal representative for U.S. Sen. <u>Lisa Murkowski</u> (R-Alaska) in her bid for the Senate in 2010. Murkowski lost the primary election to a more conservative Republican, <u>Joe Miller</u>, but won the election through a write-in campaign. Miller challenged Murkowski's write-in ballots, and Kendall worked to defend Murkowski in the <u>Alaska Supreme Court</u>, which ruled that Murkowski had won the election. [3]

2016 election

Kendall again served as Murkowski's advisor and legal representative in 2016, when Murkowski ran for re-election against Miller and a number of other candidates. Kendall told *The Hill* in July 2015 that Murkowski's campaign intended to focus on her work as chair of the Energy and Natural Resources Committee, saying, "There's no committee in the entire Senate that's more important to Alaska. ... Her focus is on making sure that Americans have access to Alaska's energy resources, and their own." [4].

Black Rock Group

In 2015, Kendall joined the Black Rock Group—a <u>Washington, D.C.</u>, consulting firm—as the group's Alaska managing director.^[1]

Bill Walker chief of staff

Kendall served as Walker's chief of staff from 2016 to 2018, when Walker's administration ended. Kendall began working as Walker's chief of staff in December 2016, taking over the job from longtime Walker aide Jim Whitaker. When he was hired for the position, Kendall told Alaska Public Media that he viewed the position as one that required facilitating staff. He said, "I don't need to be the smartest person in the room, but I like to facilitate decision-making to the right person at the right time. And I've always been able to kind of been able to bring people together to — I think — get to the right solutions." [2].

Chief of staff

In 2017, Ballotpedia identified Scott Kendall as a gubernatorial chief of staff. A chief of staff is the lead staff member of an administration and is responsible for implementing the governor's agenda.

The role is both a managerial and advisory position, although specific duties vary by administration. The chief of staff typically has the following responsibilities, according to the <u>National Governors</u>

<u>Association</u> (NGA):^[5]

- Control access to the governor and manage the governor's calendar;
- Monitor the flow of information to the governor on policy issues;
- Oversee gubernatorial Cabinet and staff; and
- Manage and communicate the governor's policy agenda to the state legislature and the public.

In terms of policymaking, the NGA notes that a chief of staff is responsible for bringing policy and communications together: "The chief is responsible for overseeing the development of the governor's policy agenda. The policy director or advisor is typically responsible for shaping the general concepts and specific details of the agenda with input from the communications director, policy staff and cabinet members. The chief often must take charge and bring the pieces together coherently." [5]





Hearing set in case challenging Alaska House candidate's win

JUNEAU, Alaska (AP) — A hearing is set for next week in a case challenging the residency of an Anchorage Democrat who won a state House race last month.

Republican Liz Vazquez, who lost the District 16 race to Democrat Jennifer "Jennie" Armstrong, brought the case along with four others who made a previous challenge to Armstrong's eligibility that was thrown out by a judge on procedural grounds.

Vazquez seeks to be declared the winner of the race. The new legislature convenes Jan. 17.

Scott Kendall, an attorney representing Armstrong, said the hearing, set for Dec. 22, will decide the merits of the case.

The lawsuit alleges that Armstrong is not qualified to be a member of the legislature, saying she "has not been a resident of the State of Alaska for at least three years immediately preceding her filing for office." It points to a social media post it says was made by Armstrong, fishing license applications and when Armstrong registered to vote.

Armstrong "did not demonstrate the intent to remain in Alaska until at least June 7, 2019, but possibly later than June 23, 2019, and as late as August 26, 2019," the lawsuit states. The candidate filing deadline was June 1.

Armstrong has said that Alaska "has been my home since May 2019."

Alaska Supreme Court rules in favor of Jennie Armstrong, clearing her to serve in Legislature

Three justices heard arguments and split 2-1 in Armstrong's favor on Friday afternoon

The Alaska Supreme Court has upheld the eligibility of Rep.-elect Jennie Armstrong, D-Anchorage, to serve in the state Legislature. **Exhibit K**

In a summary decision issued Friday, three of the court's justices voted 2-1 to uphold a lower-court decision in Armstrong's favor. The justices did not provide an immediate explanation for their decision; one will be published in the coming months.

Because two justices recused themselves and the remaining three split on the decision, it won't set precedent for future election cases, but it does clear the way for Armstrong to take office when the 33rd Alaska State Legislature convenes on Tuesday.

"I'm humbled by the trust that my constituents have placed in me," Armstrong said after the decision. "Now that this case is finally resolved, I'm excited to get to work on their behalf."

Friday's Supreme Court decision was the result of a lawsuit filed by Liz Vazquez, who lost to Armstrong by 10 percentage points in November's general election, and four of her supporters.

Citing social media posts and fishing license applications first publicized by the Alaska Landmine website, the suit asserted that Armstrong moved to Anchorage in June 2019.

Plaintiffs sued the Alaska Division of Elections, and Armstrong intervened on defense.

The Alaska Constitution requires that a legislative candidate live in Alaska for three years before filing for office with the Alaska Division of Elections.

If Armstrong had moved to the state after June 1, she would have lived here for less than three years and been ineligible. Attorneys representing Vazquez asked that the election result be thrown out and Vazquez be declared the victor.

In a brief trial last month, Armstrong and her husband, Ben Kellie, testified that she resolved to move to Alaska in May 2019, during a romantic vacation here.

She left the state briefly to gather personal belongings, then returned in early June.

Residency is defined in multiple places in state law. Attorneys Scott Kendall and Samuel Gottstein, representing Armstrong, relied on the definition set for voters, which says that changing residency "is made only by the act of removal joined with the intent to remain in another place."

The intent to remain, they argued, took place in May 2019, when Armstrong decided to move to Kellie's home in Anchorage.

Attorneys Stacey Stone, Richard Moses and Anna Cometa, representing Vazquez, argued for a different definition of residency, one billed as a "general catch-all" when it was imposed by the Alaska Legislature in 1983.

That law says someone establishes residency "by being physically present in the state with the intent to remain in the state indefinitely and to make a home in the state."

A subsection of the law says in part that a person demonstrates the required intent "by maintaining a principal place of abode in the state for at least 30 days."

The Alaska Supreme Court heard oral arguments on the issue Friday afternoon, and Stone argued that the subsection means Armstrong's residency didn't begin until June, making her ineligible for office.

Chief Justice Daniel Winfree noted that Alaska's high court has never before interpreted the 1983 definition of residency.

Last month, Anchorage Superior Court Judge Herman Walker observed that the high court has also never interpreted the "act of removal" language in the voter residency definition.

To resolve that issue, he turned to a 1909 Montana Supreme Court ruling that interpreted a law almost identical to Alaska's.

Using Montana law was inappropriate, Vazquez's attorneys said in written arguments submitted to the court.

Stone suggested that if the court decides that residency relies on intent alone, it could open the door for visiting tourists to claim residency in Alaska, making them eligible for state benefits.

Attorney Laura Wolff, representing the state, said the Division of Elections relies on the residency definition used by Armstrong's attorneys.

The Supreme Court appeared to side with that argument as well, but the reasons for the 2-1 decision were not immediately clear.

When the case was filed, justices Peter Maasen and Dario Borghesan recused themselves from hearing it, leaving Winfree, Justice Susan Carney and Justice Jennifer Henderson.

Carney said in Friday's order that she would have reversed the lower court's decision and ruled against Armstrong's residency. That left Winfree and Henderson to rule for the majority.

Rule 106(b) of the state's appellate court procedures says that if the court decides a case with only three justices presiding, and if the decision is 2-1, the "vote is decided only for purposes of that appeal and shall not have precedential effect."

That means Friday's decision is not binding on future cases involving residency challenges.
